MXP-1 Microflex® Mini Pendant Passive Loudspeaker

MXP-1 General Description

The MXP-1 is a compact pendant-style passive loudspeaker for speech and program audio reproduction in meeting rooms. With its small size and sleek industrial design, the MXP-1 is ideal for use in contemporary meeting spaces with open ceilings.

The MXP-1 utilizes an innovative Balanced Mode Radiator (BMR) driver architecture that delivers wide dispersion, extended frequency response, and powerful output. Its sensitivity provides high output with minimal amplifier power.

Up to 4 MXP-1 loudspeakers can be used with the MXN-AMP PoE-powered multichannel amplifier. The MXN-AMP provides optimized presets for all MXP loudspeaker models as well as user-configurable EQ for each speaker output. Shure audio encryption keeps audio content protected between the MXN-AMP amplifier and other Shure Microflex Ecosystem devices in the room.

The MXP-1 is available in black or white finishes and is paintable to match room decor.




Install the Pendant Loudspeaker

To install, you will need:


- Loudspeaker wire*
- Metal suspension cable or other high-strength wire*
- Mounting hardware for metal cable*

*Not included

1. Attach suspension cable (not included) to a solid structural hanging point in the ceiling using appropriate hardware. Route the loudspeaker wire next to the suspension cable.
2. Loop suspension cable from the hanging point in the ceiling through the loudspeaker's hanging tab and secure the cable.



3. Connect the loudspeaker wire to the block connector and attach the block connector to the loudspeaker.



4. **For additional mounting security:** Attach high-strength cable to 1 of the loudspeaker's secondary attachment points and to an attachment point in the ceiling. Follow any local regulations.

Connect the Loudspeaker to an Amplifier

To power loudspeakers, connect them to an amplifier. If you are connecting loudspeakers to the Shure MXN-AMP, choose the corresponding loudspeaker preset in the control software.

Troubleshooting

Problem	Solution
No sound	<p>Check cables and connections. Make sure your loudspeaker is connected to your amp and that your amp is plugged in, powered on, and routed correctly.</p> <p>Make sure the amp is not muted in the control software.</p>
Audio clipped, distorted, humming, buzzing, uneven, or too soft.	<p>Check cables and connections. Make sure your loudspeaker is connected to your amp and that your amp is plugged in, powered on, and routed correctly.</p> <p>Reduce amp gain.</p> <p>Check the quality of your audio source.</p> <p>Make sure other electrical devices aren't interfering with your audio setup.</p> <p>On MXP-5 or MXP-6, check the tap settings on your loudspeaker.</p>
Not enough bass/treble	<p>Adjust EQ of the MXN-AMP in the control software. Make sure the preset for your loudspeaker is selected on the Outputs page.</p>
